2.3 Engage in Watershed Protection and Restoration

15 Points

Program Summary: 2.3-1: Our watershed management goals and objectives are currently included as a section in our POCD. We are a Salmon River Watershed Partnership municipality, and their role in our community is to aid us in protecting, preserving and monitoring our valuable watershed assets. One such way we protect and preserve our watersheds, as stated in our POCD action plan, is through purchasing and preserving open space. The Millstream parcel is a great example of how we executed this part of our plan. The parcel is located within the Town's Future Open Space Greenway Plan and consists of open fields, forests, wetlands and a portion of Raymond Brook. This purchase further continues the Town's efforts in protecting the high water quality of Raymond Brook and the Raymond Brook Marsh. Attached is a portion of the Salmon River Watershed newsletter (completed action plan item on page 2, orange box on the left) which discusses the greenway, as well as documentation of purchase and partner letter. Also attached is our POCD with included watershed action items starting on page 11. This particular property crosses off a few of these action items, such as protecting the Town's Greenway concept, encourage the dedication of open space and conservation easements along corridors of significant value and develop an ongoing quality water monitoring program (this is through Salmon River).

Program Summary: 4.3-2: Information about currently leased farmland including plots, farm name and corresponding paperwork. We don't have high turnover on this land so no opportunity to list on Farmlink yet, but in the past they have been publicly advertised in our local paper if they become available. 4.3-7: Open space fund documentation. Current funding is \$712,454.20. Page 1 shows the amount approved in the FY 18-19 budget = \$75,000 The next page shows the balance in the account as of June 30, 2018 = \$637.454.20. The final two pages show information on the request from OSLAC. 4.3-9: Hebron has 2 community gardens. The first is for residents in our town park, Burnt Hill. The other is for youth volunteers at the Library, and their harvest goes to the Legion Hall's veteran lunches next door. (Library is town owned, not private). The first 4 pages of the PDF show advertising and community garden. Pages 5-14 are the yearly report for the Library community garden.

6.8 Implement a Community Energy Campaign

10 Points

Program Summary: Hebron Green Committee (a committee of the town) ran the "Solarize Hebron!" campaign in Spring and Summer of 2016. The target audience was single family homeowners in town and the goal was to give homeowners the resources to switch to a renewable energy source. Since the target was single family homeowners, the focus was on a direct mail campaign. We sent out flyers, postcards, and posted signage in town to notify homeowners of the program. Workshops were set up to educate residents on their options and the process. We also set up a booth at the Hebron Fair, Ted's Grocery Store and spoke to residents one-on-one. Our vendor preferred homeowners purchase the systems, which caused a few residents to seek a lease option, so in the future, we might offer both options in order to convert more residents. This was the first campaign of its kind for us, so we didn't have a benchmark to set goals against but in all, 15 systems were installed throughout Hebron! Attached are a couple direct mail pieces as well as the minutes that include the resolution to run the program by the Board of Selectmen.

7.7 Recycle Additional Materials and Compost Organics

40 Points

Program Summary: "Item Breakdown" PDF outlines the 4 non-mandatory items we recycle. The first 3 are at our Transfer Station where we recycle mattresses, electronics and plastics 3, 4, 5 and 7 (only #1 and 2 are mandatory in CT). For plastics PDF, we have a mailer that went to all households and the Hebron Goes Green site with RecycleCT widget. Electronics is on hebronct.com. Mattresses are on hebronct.com as well as byebyemattress.com which is the Mattress Recycling Council's site. The fourth item is a 3-bin composting system at the Library installed by the Green Committee with majority of the funding from the Library. Attached is a photo of final bins, the minutes where the board discussed installation (bottom of page 1) and brochure used to educate on bin usage. It is used for Library lunches, picnics and their garden as well as contribution from buildings next door.
